The EARTA luncheon and meeting was held at the Elgin Country Club. Lucy Niemeier, President, called the EARTA General Meeting to order at 12:00.

PRESIDENT – Lucy Niemeier

Lucy announced that there will be a new directory in 2025. Steve was introduced as the EARTA's presenter. He shared some of AMBA programs that members are invited to join. He shared that IRTA and AMBA are now partners. Dental and vision is now available to IRTA members and their families. The information about this is on the IRTA website. Steve recommended that members review their policies. Questions can be directed to Steve and/or AMBA directly. More information will be coming out soon. Steve reminded EARTA that the plan is very good for members. Members were encouraged to check the EARTA website for phone numbers and other contact info for AMBA as well as other pertinent entities. Steve announced that he would be available the rest of the meeting to confer with individual questions and concerns individually.

TREASURER-DAVID WEDEMEYER

David reported that the EARTA assets are held at the KCT Credit Union. As of November 14, 2024, the account balances are:

David said that on December 1, 2024, the KCT Credit Union will merge with Consumers Credit Union. KCT will be a division of Consumers, but there would be no major changes in the immediate future. This includes no name change.

The Committee is working on updating the EARTA Directory for 2025 printing, with an estimated delivery this coming summer. If you recall, we went to publishing the Directory every two years to save both time for the volunteers who assemble the information to be included as well as significant cost savings for us. Over the next several months, we will be asking you to verify your information to be included in the Directory. Just an FYI, the current Directory is the lime green covered edition with 2023 on the cover.

LEGISLATIVE & CHAPLAIN-MICK WILLIAMS

Mick reported on the IRTA's "Good Dog News" printed report. The report was about the petition for Nomination of Annuitant Trustee Candidate Rainy Kaplan. IRTA is endorsing Lorraine (Rainy) Kaplan as our

candidate for TRS Annuitant Trustee. The report contained a link to electronically sign the Petition. Only TRS annuitants can sign the petition. The deadline is January 31, 2025.

Mick reported on the Social Security Fairness Act, H.R. 82, which presents a significant opportunity to right a long-standing injustice. This legislation seeks to fully repeal the windfall Elimination Provision (WEP) and Government Pension Offset (GPO), which have unfairly reduced the retirement benefits of dedicated public servants, including retired educators, police officers, firefighters and other public servants who have served our communities.

The United States House of Representatives convenes on November 12th and will likely vote on The Social Security Fairness Act, H.R. 82. Although over 300 legislators have signed onto H.R. 82 there is no guarantee they will vote in favor of the legislation. Advocacy efforts remain critical. We need to remind Congress that both the WEP and the GPO are unjust and should be repealed.

Now is the time to urge Congress to vote YES on H.R. 82. IRTA members are being asked to ACT NOW to make your voice heard on this important issue!
