08 March 2013: Legislative Report for EARTA Board Meeting

Governor Quinn still wishes pension "reform" would occur. Speaker Madigan on the other hand wishes to have a deal that involves a casino for Chicago, some "fairness" in pension payback of the normal costs of pension by the school district (note: Chicago pays for their own.) AND he also wishes to reduce the cost of health insurance for the State of Illinois ... ie., trade the reduced COLA for health insurance. The speaker can say: I've done everything in my power to shift costs. He likes to play the political game all the way through. Thus, we are entering into a protracted court battle. Our recent legal opinion states, in effect, retirees are "safe" from the legislation 18 to 20 bills, out there. Madigan will say: Let the courts decide – I tried – the courts have done it.

For the court battle, we need a sizable legal defense fund. The goal is \$10.00 per member. With 34,000 IRTA members, we could reach the goal of \$340,000.00. So far, we have \$100,000.00 ... that's about \$3.00 per member. There will be a Legal Defense Fund table at the Convention.

You can be proud of your Association. We are in the forefront of retiree rights. We are obtaining the legal opinions. The Senate views many House bills as unconstitutional.

A bit of good news is that the Governor's budget includes approximately \$6 Billion in payments to TRS.

You can "watch" a live legislation session, go to ILGA.GOV ... watch the leg.house and click on audio/video. About 5,000 bills in a session are "fetcher" bills ... these are written to obtain a contribution. The Legislative Reference Bureau actually writes the bills and they must have a number to be introduced. Everything has a deadline, but the 3rd reading deadline can be extended. When the "deals" are done legislation can move very rapidly. They can "set up" several shell bills at once and change one word as "place holders" and within a half hour when things move, it's all accomplished before there is time for much response. The pensionable salary amendment of \$113,000 passed March 7, 2013; two other amendments failed.

Regardless of the rumors you have heard, TRIP is paying within 60 days. The TRIP HMO is paying within 30 days.

There are 18,500 members using Voter Voice. If you change your email, you have to call it in. If you open it, remember to SEND it!!!

IRTA PAC approved giving \$1,000 to Sheila Simon for her campaign.

Two resolutions from IRTAPAC were sent to the Executive Committee for consideration at the Convention:

- 1. Enable endorsement of non-incumbents
- 2. Enable endorsement for office of Governor
