13 May 2016: Legislative Report for EARTA Board Meeting

"Politics" continues in Springfield without much governing or legislation. Illinois is on "autopilot" without a budget into this mess in the first place, but and payments are made based on court orders and lawsuits. As moral hazards are "constitutionally" balanced highlighted in demonstrations some emergency funding is authorized. Usually it is reduced by as much as 50% or more. Stopgap piece meal measures have been passed for highereducation and to keep

The budget impasse "deals" and rumors abound including 4 or 5 new casinos. Local funding (if over 6%) "spiking" for higher pensions amounts ... a state tax increase to 4.85% ... taxing higher retirement income ... taxing

Most of the "rumors" to reduce the pension deficit would be unconstitutional, such as:

"consideration", COLA tied to salary freezes, lump sum payments at a reduced amount. Retirees can already select a lump sum amount. A 401K type option or combination with a private account are not based on actuarial science and do not consider adverse selection. These selections might include health, chronic illness, disability, mental illness, revenge divorce, planned euthanasia, or suicide, etc. HB1334 eliminates double dips. It might be constitutional depending on the definition of retirement.

Another bill to watch is SB289 which includes the authority to skip pension payments. The pension holidays got us Rauner can claim that he offered a pension payments are not included.

It is important to refute propaganda with some facts presented by Ralph Martire of the CTBA. "Compared to the rest of the nation, Illinois is a very low

spending and small government state. Illinois ranks 28th in General Funding on Services per capita and 36th in General Fund Spending on Services as a share of GDP. In 2011, Illinois ranked 49th in number of state workers per 1,000 residents. In 2014, Illinois ranked 5th nationally with a Gross State Product in excess of \$745 **B**illion. This is the 20th largest economy of any nation in the entire world. Illinois total state and local tax burden ranked in the bottom 10 of all states. Illinois has the second lowest tax burden in Midwest next to Missouri. The dollar shortfall in State per pupil K-12 Education Funding to meet the Adequate Education Standard by fiscal year: 2014 --**\$2,553.00**; 2015 ---**\$2,747.00**; 2016 ---\$2,946.00. They have been starving education since 2003! Increasing taxes the right way does not hurt the economy. States with "High Rate" taxes are outperforming the others." Please don't believe or repeat the propaganda that states misrepresentation. These are the facts from CTBA.

Senators Noland and Holmes (two of our endorsed candidates) both voted for the new P-12 formula which passed the Senate. No increase in funding included in the bill.

Please consider making the IRTAPAC automatic monthly contribution of \$1.00. You CAN afford it. Political action is very important during this "dark" time. WE must support retiree's views! We are

agents of democracy in the public arena for public education. We support the public good.


